Respected Madam / Sii,

Your kind attention is invited to this Ministry's D.O. letter of even number dated 13.07.2023 & 14.08.2023 regarding conduct of Veer Gatha Project (3.0). As per Concept Note, the timeline with regard to conduct of activities at school level is till 31.08.2023. Considering poor participation of school from all the States / UTs, the competent authority has decided to extend the timeline for conduct of activities at school level till 15.09.2023. Therefore, revised timeline for conduct of activities at school level and uploading of entries on MyGov Portal is from 28.07.2023 to 15.09.2023.

- 2. Considering that participation of schools from all the States / UTs is very poor, Education Department / SPD / State Nodal Officer of all States / UTs are requested to look into this matter personally and ensure maximum participation. MoD has made WhatsApp groups also to efficiently disseminate the information (with regard to Veer Gatha Project) to all the State / UT / District Nodal Officers. Therefore, Education Department / SPD may direct all the State / UT / District Nodal Officers to do the needful at their end to ensure maximum participation.
- 3. As per concept Note, the State / UT / District Nodal Officer have prime role in the conduct of Veer Gatha Project (3.0). However, some States / UTs have not furnished the data till date. Therefore, the States/UTs who have not furnished information about State/UT / District Nodal Officers are again requested to furnish the same without further delay.
- 4. A meeting under the Chairmanship of Secretary (SE&L) has been scheduled to review the progress for which date and time will be intimated shortly. All the officials of Education Department / SPD / State Nodal Officer of all States / UTs are requested to make it convenient to attend the aforesaid meeting without fail. The link for the meeting will be shared by Email separately.
- 5. In view of above, all the State Governments / UT Administrations, MoD, CBSE, NCERT, KVS and JNV are requested to look into the matter personally and do the needful.
